SUMMARY

Offer Price and net proceeds from the Share Offer

- The Offer Price has been determined at HK\$0.325 per Offer Share (excluding brokerage of 1.0%, SFC transaction levy of 0.0027% and Stock Exchange trading fee of 0.005%).
- Based on the Offer Price of HK\$0.325 per Offer Share, the net proceeds from the Share Offer to be received by the Company, after deduction of underwriting fees and other estimated expenses payable by the Company in connection with the Share Offer, is estimated to be approximately HK\$58.7 million. The Company intends to apply such net proceeds in accordance with the purposes set out in the paragraph headed “Net Proceeds from the Share Offer” below.

Applications under the Public Offer

- The Offer Shares initially offered under the Public Offer have been significantly over-subscribed. A total of 47,513 valid applications have been received pursuant to the Public Offer on **WHITE** and **YELLOW** Application Forms and by giving **electronic application instructions** to HKSCC via CCASS for a total of 2,362,128,000 Public Offer Shares, representing approximately 59.05 times of the total number of 40,000,000 Public Offer Shares initially available for subscription under the Public Offer.
- Due to the significant over-subscription in the Public Offer, the reallocation procedures as described in the section headed “Structure and Conditions of the Share Offer – The Public Offer – Reallocation” in the Prospectus have been applied. As the number of Offer Shares validly applied for in the Public Offer represents approximately 59.05 times of the number of Offer Shares initially available under the Public Offer, 120,000,000 Shares have been reallocated to the Public Offer from the Placing, so that the total number of Offer Shares allocated to the Public Offer has been increased to 160,000,000 Offer Shares, representing 40% of the total number of Offer Shares available under the Share Offer.

The Placing

- The Placing Shares initially offered under the Placing have been slightly over-subscribed, representing approximately 1.02 times of the total number of 360,000,000 Offer Shares initially available under the Placing. Following the reallocation described above, the final number of Placing Shares allocated to 189 placees under the Placing is 240,000,000 Placing Shares after reallocation to the Public Offer, representing 60% of the total number of Offer Shares available under the Share Offer. A total of 82 placees have been allotted five board lots or less of Placing Shares, representing approximately 43.4% of total number of placees under the Placing. A total of 1,712,000 Placing Shares have been allotted to these placees, representing approximately 0.7% of the 240,000,000 Placing Shares after reallocation to the Public Offer.

- The Directors confirm that, to the best of their knowledge, information and belief having made reasonable enquiries, no Offer Shares under the Share Offer have been allocated to applicants who are Directors, existing Shareholders or beneficial owners of Shares and/or any securities of the Company's subsidiaries and core connected persons of the Company or their close associates within the meanings of the Listing Rules, whether in their own names or through nominees. - 47,483 valid applications for a total of 1,863,128,000 Public Offer Shares were for the Public Offer with an aggregate subscription amount based on the maximum Offer Price of HK\$0.34 per Offer Share (excluding brokerage fee of 1.0%, SFC transaction levy of 0.0027% and Stock Exchange trading fee of 0.005%) of HK\$5.0 million or less (equivalent to approximately 93.16 times of the 20,000,000 Offer Shares initially available for allocation in pool A of the Public Offer); and
